The **Sioux Empire Kennel Club, Inc.** will hold its **2026 All-Breed Dog Show, Obedience Trial and Rally Trial October 23<sup>rd</sup> (two shows on Friday!), 24<sup>th</sup>, and 25<sup>th</sup>** in the Expo Building at the WH Lyon Fairgrounds (12<sup>th</sup> Street at I-29) in Sioux Falls. Our 2025 show was fabulous, and we expect another great show this fall! We have the NOHS all three days of the show. Please take a minute to read the information below and then complete the application and mail it in by the deadline of **October 7, 2026**.

**Details you need to know about the SEKC Annual Dog Show and Obedience / Rally Trials:**

- Plenty of on-site parking.
- **Vendor set-up time on Thursday from 1pm –10 pm and Friday from 6am – 8am only.** No vehicles or trailers are to be left in the building after designated set-up times.
- Vendor booth sizes; price includes access to one electrical outlet if needed. Booths will be indoors.  
100 square feet (10 x 10) = \$100 for 3 days  
200 square feet (20 x 10) = \$200 for 3 days  
300 square feet (30 x 10) = \$300 for 3 days  
  
FOOD TRUCKS = \$200 for 3 days (Will be outdoors. Must provide a generator if power requirements exceed 110.)
- Please indicate on your registration form if you need electricity.
- Vendor booth spaces will be assigned.
- Vendors who are not assigned a space prior to the show will not be allowed to set up.
- Tables will not be provided. Extension cords will not be provided. Folding metal chairs will be available.
- If you would like to provide a raffle item for the event, please bring it to the SEKC information table (near the superintendent table) Thursday night or early Friday. *You are not required to provide a raffle item.*
- Show venue will be locked at 10pm to 6am Thursday, Friday and Saturday nights and opened at 6a the following morning.
